



# INTRODUCTION TO LEGAL ENGLISH

**Total Hours: 40** (32 Lectures/Seminars + 8 Preparation and Study)

Language requirements: Intermediate Level of English

Audience: the course is open to everybody and in particular to professionals

with a legal background, undergraduate and graduate students of

the Facoltà di Scienze Economiche, Giuridiche e Politiche.

Registration fee: 350 Euro

*Introduction to Legal English* is a course on U.K., U.S. and international Legal English that combines lectures and interactive teaching sessions.

The course is organised and mainly held by Ms Anna Maria Mancaleoni, Professor of Private Comparative Law at the University of Cagliari and Lawyer, and Ms Chiara Rotondi, Lawyer, Italian-English certified legal translator and Legal Research Assistant at the University of Cagliari.

The course is divided in 8 units and sub-units. Some units deal with topics of general interest: features, similarities and differences between the common law and the civil law legal systems, EU law, conflict of law rules, business communication; some units are specifically focused on contract law and judicial practice.


Each topic will be introduced by a general lecture on the relevant legal framework, followed by a more detailed analysis of the language.


The lectures and the seminars will be held partly in Italian and partly in English. Participants who do not feel overly confident in English will have the opportunity to obtain clarifications in Italian. Conversely, those who are reasonably fluent in English will gain a comparative knowledge of the legal systems involved whilst improving their legal language skills. Legal English materials will be made available.











The course can also be a preliminary step for the preparation of TOLES (Test of Legal English Skills).

At the end of the course the participants who attended at least 6 units or subunits (24 hours in total) will be given an attendance certificate.

Lawyers attending the course will be entitled to 10 training credits.

Accountants will be entitled to a certain number of training credits that are currently being decided by their professional organisation.

Students seeking the recognition of credits will have to make a specific request to that end to the person or body responsible before the course begins. The right to credits is subject to the relevant university regulations.


The course will start at the end of October and will take place on Thursday/Friday afternoons and Saturday mornings, as follows:


